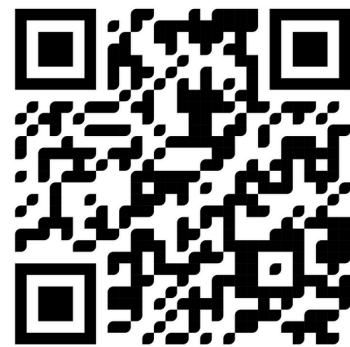
# GBS Store

## HOW TO BECOME AN AUTHORIZED GBS STORE PARTNER?



- Ensure that GBS partners must have a designated area with ample storage space for glass waste collection to prevent bottle contamination.
- Authorized GBS Partners must provide necessary documentation such as a DTI Permit and two valid ID's or Barangay clearance/cedula.
- All GBS store partners must be willing to sign a contract agreement and must comply with the policy, terms, and conditions of BBPD.
- GBS store must ensure that the purchase of glass waste, as much as possible clean (no caps, labels, contaminants- cigarettes, mosquito coil (katol), pebbles, soil, toxic chemicals, animal or human waste, etc.) whether it is broken or not.
- The GBS Store will separate the glass waste from other types of waste such as papers, plastics, and chemical substances, and place it in the provided sacks and must ensure that it is accessible and not obstructed at the time of collection.
- The authorized GBS store partner should buy the processed glass waste bottles at standard rate of ₱1.00 per kg and the BBPD will buy it from the GBS store for ₱1.50 per kg.
- Glass waste is limited to food and beverage containers such as food jars, alcoholic drinks bottles, soft drinks bottles, condiments containers, and broken drinking glasses.
- The collected bottles should be sold only to the authorized GBS collectors who wears BBPD shirt; individual collectors without proper attire shall not be entertained.
- GBS partner stores must meet and maintain average performance of 150 kg each week or 600kg per month.
- The GBS partners who met the average performance range for glass collection is eligible to win prizes, incentives, and additional capital.

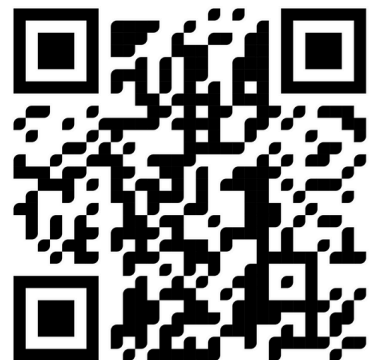

## How to become a GBS Bar, Hotel, Resort & Restaurant Partner?

- Authorized GBS Partners must provide necessary documentation such as a DTI Permit and two valid ID's or Barangay clearance/cedula.
- All GBS partners must be willing to sign a contract agreement and must comply with the policy, terms, and conditions of BBPD.
- The BBPD will purchase/buy the clear/ transparent glass waste from our GBS partners - bars, hotels, resorts, and restaurants at the set price range of P1.50 per kilo.
- The BBPD consolidates and pays the GBS partners upon collection of the glass wastes.
- The GBS partners shall separate the glass waste from other types of waste such as papers, plastics, and chemical substances, and place it in the provided containers and must ensure that the containers/sacks are accessible and not obstructed at the time of collection.
- The GBS partners must notify the GBS collector of any changes that occurred prior to the collection dates.
- GBS partners should know that accepted glass waste is limited to food and beverage glasses such as food jars, alcoholic and soft drinks bottles, condiments containers, and broken drinking glasses.
- GBS partners must comply to the policy that the glass wastes will be collected by the sole and authorized GBS collector that wear BBPD shirt; individual collector without proper attire shall not be entertained.
- All GBS store partners must be willing to sign a contract agreement and must comply the policy, terms, and conditions of BBPD.
